Consignment Parties

In accordance with this agreement, the Consignor gives DBC the exclusive right to display and sell all mutually agreed items. **Initial: _____**

Consignment Period

Consignment is for a period of no less than 60 days. Items picked up prior to the 61st day are subject to an early pick-up fee equal to 25% of the items' current selling price.

Beginning on the 61st day, the Consignor has a seven-day (7 day) grace period to reclaim any unsold items. The Consignor is solely responsible for reclaiming unsold items during this time. Please keep track of your original consignment date and pick-up date. An appointment is necessary, should the Consignor wish to pick up their items. DBC is not responsible for contacting Consignors regarding expiring items. On the 68th day, any unclaimed items will convert to store property. DBC has sole discretion to keep, sell or donate unclaimed items.

Holiday items, as designated by DBC, must be picked up no later than seven days (7 Days) after the corresponding holiday. On the eighth day after the holiday, unclaimed items will convert to store property. DBC reserves the right to pull holiday items immediately following the holiday. **Initial: _____**

Selling Price - Disclaimer and Limitation of Liability

DBC shall determine the selling price of all items. DBC does not employ professional appraisers and does not guarantee the accuracy of item valuations or pricing. All pricing is determined based on DBC's experience, judgement, current market trends and research. This is not to be considered a formal appraisal.

At the end of 35 days, an automatic price reduction of 20% will be in effect. No more than a 20% price reduction will be made without mutual agreement between DBC and Consignor.

DBC retains 50% of the proceeds from the sale of each item consigned. DBC reserves the right to add a buyer fee onto the sale price of each item consigned. This fee is not paid by the Consignor nor subject to the 50-50 split agreement.

By signing this agreement, you agree to hold DBC harmless for any errors, omissions, or discrepancies in pricing or valuation. DBC assumes no responsibility for any loss or damages resulting from the pricing of consigned items. **Initial: ___**

Accounting/Payout

Consignor will receive online access via email to monitor their items.

Proceeds from the sale of the consigned items will be issued by check and available for pick-up on or after the 5th day of the month following the month in which the sale occurred (Example: Items sold in July will be paid out no later than August 5th). Local consignors are asked to pick up the checks in store. For Consignors residing outside the local area, checks can be mailed to the address on file, upon request.

Accounts that have been inactive for two years will be closed and all money will become the sole property of Dovetail Boutique Consignment. **Initial: ___**

Lost/ Stolen/ Damaged Items

Merchandise that is lost, stolen or damaged shall be considered as having been sold. Dovetail Boutique Consignment shall pay the Consignor as if the merchandise had been sold up to a maximum of \$1000.00 per item. The Consignor shall be paid the previously agreed upon percentage of sale, that amount shall be paid within the regular terms of Consignee/Consignor payout. Natural disasters including flood, earthquake and acts of terrorism are exempt. **Initial: ___**
